**Update of Sierra:** Hope to have access to a test database (test records, not our records) in January. Before Sierra we will have to upgrade to 2011 release. Tentatively we would switch to Sierra in June 2012.

**Web Dewey:** Julie will send out a test login for us to try. We will need to buy 2 different logins as EC uses a separate OCLC holdings code. Hope to have full 2-9 concurrent user subscription in January, either via OCLC or a separate Internet login.

**Indexing:** The Committee spent considerable time reviewing MARC fields subfields and assigning them to various indexes in preparation for reindexing.

**Blu-ray/DVD combo rules clarification:** Bib. Committee recommendation is that if the materials come as a set (1 regular DVD + 1 Blu-ray DVD), they should be cataloged on a single bib. and circulated as a single item.
