Agenda: motion to approve (Helen/Marguerite0, approved by voice

Minutes of previous meeting: Jeanne (CF) was not present (delete), Jane Miller was present (add); motion made to approve w/corrections by Jeanne/Helen, approved by voice.

DECISIONS MADE:

- Motion made by Marguerite that we add a 655 _7 Juvenile kits and strip out juvenile kits as a subdivision, seconded by Jon. Approved.
- Motion made to approve by Donna that we retain Mummy films, Our Gang films & Bowery Boy films as local genre headings coded as 655_7|2local, seconded by Jeanne. Approved.

Current business:

Sierra: overview-- customize the dashboard by individual logins; these logins will be redone in May, functions tied to individual logins, macros may not move over, templates should. InnView not available yet, timeline--June switch, but must be ready to go live-- lots of testing yet to be done.

Reindexing: on hold, waiting to see if we can do it ourselves in Sierra.

RDA update: LoC implementation date is 3/31/13. GMD and 336, 337, 338 fields will need further discussion by committee. Continue to strip 336-338 fields until further discussion at next meeting. Keep the GMD in the 245 field.

Web Dewey: available for use, 2-9 users--one log-in for all users. Please remember to log out when not using.

Local free-floating subdivision: the committee did not approve either |v Young adult fiction or |v Young adult literature as subdivisions. Committee agreed that a local subject heading of "young adult literature" could be added; this would enable staff and customers to keyword and/or advance search in those areas and it would be consistent with the already existing |v Young adult fiction. It could be coded as: 655 _7 Young adult literature. Donna will take this back to the LEPMPL staff for their input/approval.

Juvenile kits: as a free-floating subdivision, not authorized at this time (140 entries). Create a 655 _7 Juvenile kits.|2local. Motion made by Marguerite that we add a 655 _7 Juvenile kits and strip out juvenile kits as a subdivision, seconded by Jon. Approved.

LC & LCGFT changes: canceled genre films, i.e. Zorro films become Swashbuckler films. Julie will be stripping out the genre headings from the list. There are three exceptions which we will code as 655 _7 Mummy films.|2local ; 655 _7 Bowery Boys films.|2local ; 655 _7 Our Gang films.|2local. Motion made to approve by Donna that we retain Mummy films, Our Gang films & Bowery Boy films as local genre headings coded as 655 _7|2local, seconded by Jeanne. Approved. Julie will work on the list, deleting invalid genre headings.

Theatrical trailers: being added to LEPMPL dvds in the 856 field, do not delete.
