New Business

- 1. Downloadable media patron access restrictions: Motion to establish MORE wide policy to allow individual libraries to block individual's access for Freegal but not overdrive and Freading.(EC/CF) passed. Motion made to accept the executive recommendation minus the Freegal restriction for downloadable services. (EC/PH) passed; Thompson abstained. If you want to follow through with this restriction in your individual libraries, each library will need to amend their individual circulation policy.
- 2. Freegal Music Enhancement Program Using regular and extra end of the year hours at Eau Claire, Eau Claire staff is working to do as much searching and preparation of as many MORE CD titles (all of MORE not just Eau Claire items) as possible before the end of the year. (Also, Donna Swenson at Eau Claire has begun adding Freegal connections with new Eau Claire music CD items she catalogs.) Each CD title that is available in Freegal will have a link to its specific item record in Freegal (not just to Freegal in general). Until then, Freegal access information will be suppressed. This week, Eau Claire has completed all 2013 MORE music CDs to date and has begun working on 2012. It is hoped, in 2014, to involve the cooperation of other MORE library staff and others to get as many records tagged as possible.
- 3. Election of officers: Recommend a slate of candidates for 2014 MORE offices. Nancy Miller asked that this information be supplied prior to Directors Council meeting.
