### **Adding hardcovers to paperback records practice**

Generally speaking paperbacks are added to hardcover records, but we don't argue the point when the publisher is the same and the paperback record is already in. I actually didn't know there are a lot of simultaneous hardcover/paperback releases so this may be something for the bib committee to discuss. To me this situation falls under the procedure of whoever catalogs the item first catalogs what they have. Those who come after add to it if it's the same or creates a new bib if it's different. Here I would add the qualified hardcover ISBNs and transfer your order and item records. The only difference in the bib record would be the number of pages and that's not worth arguing over, especially since the majority holds the paperback copy.

This procedure of adding paperbacks to hardcovers was made when hardcovers were always published first and paperbacks came along 6-12 months later and we were trying to avoid duplicate records. Now that that has changed some we may want to rework that procedure.
