- I. **Call to Order:** Lynn Gates called the meeting to order at 1:05 p.m.
- II. **Establish a Quorum:** Completed
- III. **Certification of compliance with open meeting law:** Compliance was verified
- IV. **Modify/Approve Agenda:** A motion to approve the agenda was made by Jennifer R.; seconded by Meagan B. The motion carried.
- V. **Modify/Approve Minutes from May 15, 2025:** A motion to approve the minutes with changes was made by Meagan B.; Seconded by Deb F. The motion carried.
- VI. **Update on Wisconsin Cataloging Best Practices:** The 3 year grant to study cataloguing practices throughout Wisconsin concluded in June of 2025. A website www.wicatalog.org/ was established to gather all the findings and recommendations for streamlining cataloging terms through the states various systems.
- VII. **Discussion on large print vs larger print.**

- a. Background: WICat recommendation differ from previous decision from Jan 25, 2022 meeting.
- b. Topic to be tabled until the next committee meeting so all members can review WICat recommendations, check larger print usage in member's libraries and for IFLS to determine the exact number of items we are talking about.

VIII. Discussion on MORE Award local notes:

- a. Potential awards to add to bib records Asian Pacific Awards, ALA Awards (various lists), Comics and Graphic Novels.
- b. Motion made for IFLS to update the example (remove Golden Globe) in the template and for the awards list to be later updated from the list that Sara will send out to committee members for potential inclusion along with the volunteers who will update the awards yearly. Motion made by Meagan B.; seconded by Deb F. Motion carried

IX. Backstage and subject headings with “|v Folklore |v Juvenile fiction” string: Committee recommended that Backstage break the |v Folklore |v Juvenile fiction string into two separate strings going forward rather than removing |v Juvenile fiction from the record.

X. Discussion on |v Juvenile drama vs |v Juvenile films subdivision:

- a. Background: The common practice of using Juvenile films started because of a mistake in LC instructions. The authorities clarify: Juvenile films is used as a form subdivision under subjects for nonfiction films, produced especially for children. Juvenile drama subdivision under names of countries, cities, etc., names of individual persons and corporate bodies and under classes of persons, ethnic groups, names of deities and mythological or legendary figures, individual and groups of fictitious and legendary characters, and topical headings for fiction films produced especially for children.

- b. Motion made to follow the accepted rules regarding |v Juvenile drama (fiction films) and |v Juvenile films (non-fiction films) as we are already doing in the adult videos. Motion made by Meagan B.; seconded by Jen R. Motion carried.

XI. Discussion on Mount Denali and Gulf of Mexico subject headings:

- a. LOC has updated Mount Denali and Gulf of Mexico subject headings to Mount McKinley and Gulf of America.
- b. Motion made to keep the traditional names (Mount Denali and Mexico, Gulf of) in a 150 field and the new names (Mount McKinley and America, Gulf of) in a 450 field. Motion made by Meagan B.; seconded by Jen R. Motion carried.
